V. Call For New Business
A. Department Reports

- When digging through files Farrell found 29 possible Tribal members who will be on dialysis in the future because of lack of follow-up. Farrell is to look into a modern medical machine to be used for diabetics on dialysis, this machine will have other uses also that helps stimulate muscles in the body.
- A temporary Doctor will be coming in to work for 6 months, his name is Dr. Paul Newman.
- All X-Rays are being done in house now by Shawn Eugene and Dr. Helland.
- Parking Lot lights are now working at the Visalia Clinic. There is still a need for the signs to be visible.
- Flu shots are available.
- Dr. Pearson from Modesto has replaced Dr. Shaw.
- Transporter Elizabeth Perez is Acting Transporter for Edna Franco and Lola Ogden.
- Cars: our Health cars are being parked in the Tribal Parking area because the construction crews asked for them to be moved. They are to be moved back to the Health Center today January 5, 2005.

- MOTION #3 Vincent Burrough/Lucille Apalatea motioned to approve the Supervisors Reports. The vote was 5-0-0, motion carried.
  - Only Contract Care patients will be transported, not Direct Care as we are limiting transport to contracted patients.
  - Dental: today the board is to interview a Dentist from Palm Dale.
  - Fiscal: Software upgrades are available and someone to work with them.

- HIPPA: three new doors will be installed in the Medical Clinic with magnetic security locks installed to be in compliance with HIPPA. Staff will be required to use magnetic cards for access with patients allowing more privacy. Melissa Hunter and Patsy Franco's areas will also be enclosed for more privacy.
- Human Resources: we are currently recruiting staff for: Fiscal Clerk, Community Health Representative, Billing & Collections Specialist, Assistant Referral/CHS Clerk, Executive Secretary and Director of Mental Health.
