DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 27.23 million with more than 891,000 deaths.

The total number of cases in the U.S. increased from 6,132,074 as reported on Friday 9/4/2020 to 6,287,362 reported today. The number of deaths in the U.S. increased from 186,173 to 188,688.

On Monday, August 31, the U.S. Department of Housing and Urban Development (HUD) Secretary Ben Carson announced that HUD has awarded a total of \$100 million to Tribes across the Nation as part of HUD's Indian Community Development Block Grant Imminent Threat program (ICDBG-CARES). This funding helps address problems that pose an imminent threat to public health or safety of Tribal residents and will be used to help Tribes prevent, prepare for, and respond to COVID-19. California has a new blueprint for reducing COVID-19 in the state with revised criteria for loosening and tightening restrictions on activities. To find out how businesses and activities can open in your county, click HERE.

The National Indian Health Board (NIHB) is hosting a webinar on eldercare during the COVID-19 pandemic. According to the Centers for Disease Control and Prevention (CDC) the risk for severe illness from coronavirus infection increase with age. For example, people in their 50s are at higher risk for severe illness than people in their 40s. Similarly, people in their 60s or 70s are, in general, at higher risk for severe illness than people in their 50s. The greatest risk for severe illness from COVID-19 is among those aged 85 or older. This webinar will present ways we can help to prevent illness, and care for our elders during these unprecedented times. hear presenters will discuss topics ranging from caring for elders during the pandemic, preventing infection among this vulnerable population and tips for caregivers. COVID-19: U.S. at a Glance*

- Total cases: 6,287,362
- Total deaths: 188,688
- Jurisdictions reporting cases: 55 (50 states, District of Columbia, Guam, Puerto Rico, the Northern Mariana Islands, and the U.S. Virgin Islands)

*As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020. The position statement included a case definition and made COVID-19 a nationally notifiable disease.

A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

A probable case or death is defined by:

i) meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or ii) meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or iii) meeting vital records criteria with no confirmatory laboratory testing performed for COVID19. State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.

Total Number of COVID-19 Cases in the US Reported to the CDC, by State/Territory Territories AS FSM GU MP PR PW RMI VI Total Cases



CALIFORNIA

As of September 7, 2020, there were a total of 737,911 positive cases and 13,758 deaths in California.

Ages of all confirmed positive cases:

• Age 0-17: 75,198 cases

• Age 18-49: 442,946 cases

• Age 50-64: 139,563 cases

• Age 65 and older: 79,301 cases

• Unknown/Missing: 903 cases

Gender of all confirmed positive cases:

• Female: 372,728 cases

• Male: 358,617 cases

• Unknown: 6,566 cases

Lab tests reported statewide: 12,267,948

Twenty-five public health labs in California are testing samples for COVID-19. These labs include the California Department of Public Health's Laboratory in Richmond, Alameda, Butte, Contra Costa, Fresno, Humboldt, Imperial, Long Beach, Los Angeles, Monterey, Napa-Solano-Yolo-Marin (located in Solano), Orange, Riverside, Sacramento, San Bernardino, San Diego, San Francisco, San Joaquin, San Luis Obispo, San Mateo, Santa Clara, Shasta, Sonoma, Tulare and Ventura County public health laboratories. The Richmond Laboratory will provide diagnostic testing within a 48-hour turnaround time. This means California public health officials will get test results sooner, so that patients will get the best care.



Of these, 664 patients have tested positive for COVID-19 and 8,880 have tested negative for COVID-19.







Racial distribution of confirmed COVID-19 cases and deaths in California






Two sources for tracking American Indian and Alaska Native (AIAN) cases reported in California

Data from the Indian Health Service (IHS) include positive cases reported by Tribal and Urban Indian Health Programs.





In California:


- 0.4% of confirmed cases are hospitalized
- 0.1% of confirmed cases are in the Intensive Care Unit
- 1.9% of cases have died

Case and death disparities:


- For all adults ages 18+, Latinos and African Americans are dying at disproportionately high rates. The proportion of COVID-19 deaths in Latinos is more than 1.3 times their population representation across all adult age categories.
- More males (58%) are dying from COVID-19 than females (42%).




CDC data show that AIAN in California are testing positive for COVID-19 at rates lower than their proportion of California's population and dying at rates that are higher. This includes a total of 2,521 cases and 72 deaths.




