

## DAILY HIGHLIGHTS

Globally, COVID-19 cases have surpassed 31.66 million with more than 972,000 deaths.

The total number of cases in the U.S. increased from 6,874,982 as reported on Wednesday 9/23/2020 to 6,916,292 reported today. The number of deaths in the U.S. increased from 200,275 to 201,411.

### COVID-19: U.S. at a Glance\*

- Total cases: 6,916,292
- Total deaths: 201,411
- Jurisdictions reporting cases: 55 (50 states, District of Columbia, Guam, Puerto Rico, the Northern Mariana Islands, and the U.S. Virgin Islands)

\*As of April 14, 2020, CDC case counts and death counts include both confirmed and probable cases and deaths. This change was made to reflect an interim COVID-19 position statement issued by the Council for State and Territorial Epidemiologists on April 5, 2020. The position statement included a case definition and made COVID-19 a nationally notifiable disease.

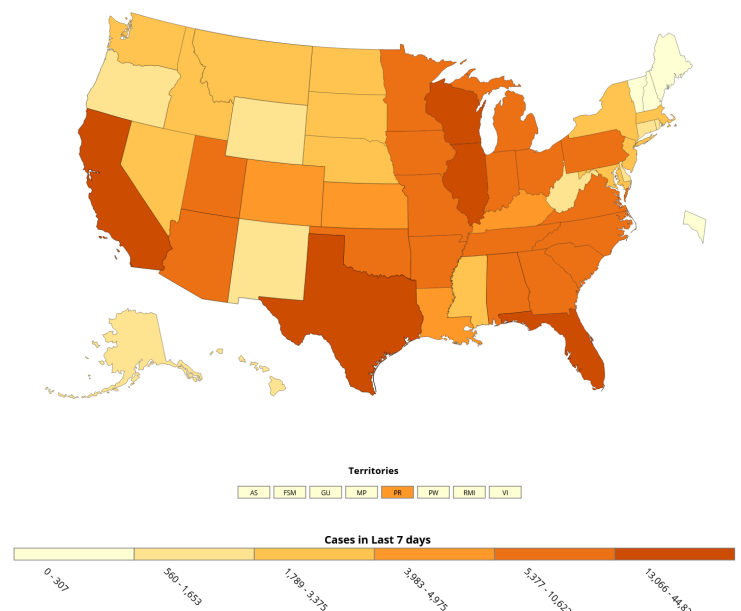
A confirmed case or death is defined by meeting confirmatory laboratory evidence for COVID-19.

A probable case or death is defined by:

- meeting clinical criteria AND epidemiologic evidence with no confirmatory laboratory testing performed for COVID-19; or ii) meeting presumptive laboratory evidence AND either clinical criteria OR epidemiologic evidence; or iii) meeting vital records criteria with no confirmatory laboratory testing performed for COVID-19.

State and local public health departments are now testing and publicly reporting their cases. In the event of a discrepancy between CDC cases and cases reported by state and local public health officials, data reported by states should be considered the most up to date.

US COVID-19 Cases Reported to the CDC in the Last 7 Days, by State/Territory

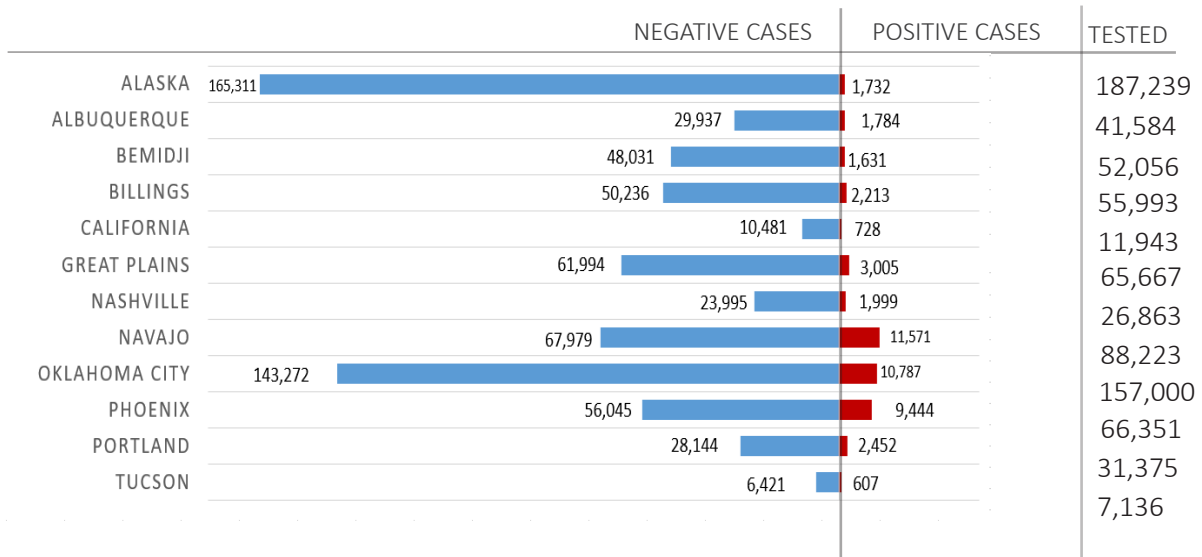

## CALIFORNIA

As of September 23, 2020, there were a total of 790,640 positive cases and 15,314 deaths in California.

Ages of all confirmed positive cases:

- Age 0-17: 81,545 cases
- Age 18-49: 474,158 cases
- Age 50-64: 149,356 cases
- Age 65 and older: 84,659 cases
- Unknown/Missing: 922 cases

Gender of all confirmed positive cases:

- Female: 399,084 cases
- Male: 384,959 cases
- Unknown: 6,597 cases

Lab tests reported statewide: 13,952,857

Twenty-five public health labs in California are testing samples for COVID-19. These labs include the California Department of Public Health's Laboratory in Richmond, Alameda, Butte, Contra Costa, Fresno, Humboldt, Imperial, Long Beach, Los Angeles, Monterey, Napa-Solano-Yolo-Marin (located in Solano), Orange, Riverside, Sacramento, San Bernardino, San Diego, San Francisco, San Joaquin, San Luis Obispo, San Mateo, Santa Clara, Shasta, Sonoma, Tulare and Ventura County public health laboratories. The Richmond Laboratory will provide diagnostic testing within a 48-hour turnaround time. This means California public health officials will get test results sooner, so that patients will get the best care.

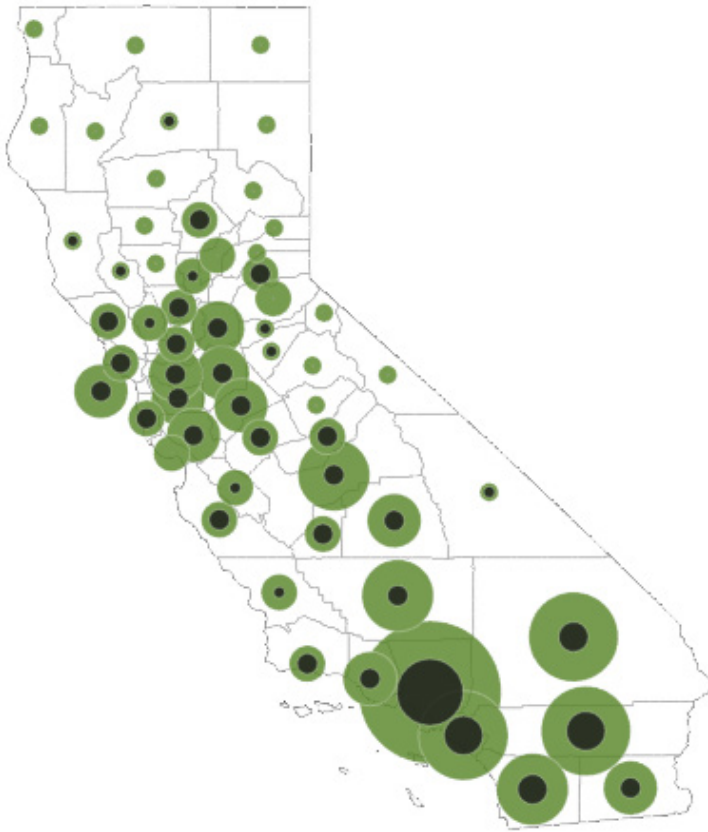

## INDIAN HEALTH SERVICE CALIFORNIA AREA

11,943 Tribal or Urban Indian Health Program patients in the California Area have been tested for COVID-19 as of 9/22/2020.

Of these, 728 patients have tested positive for COVID-19 and 10,481 have tested negative for COVID-19.

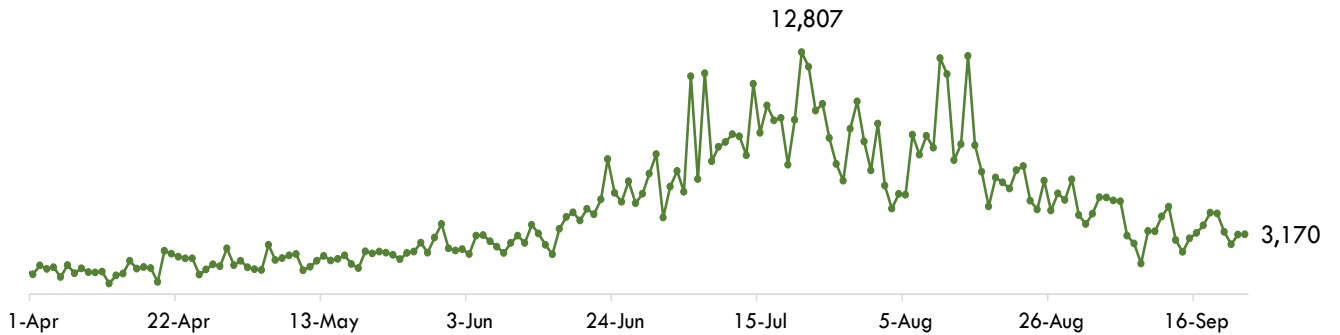

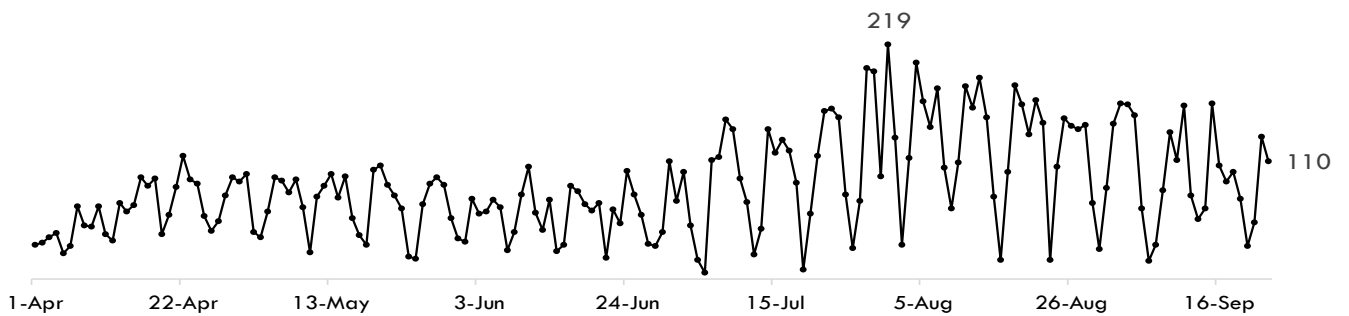

New Confirmed Cases in California by Date



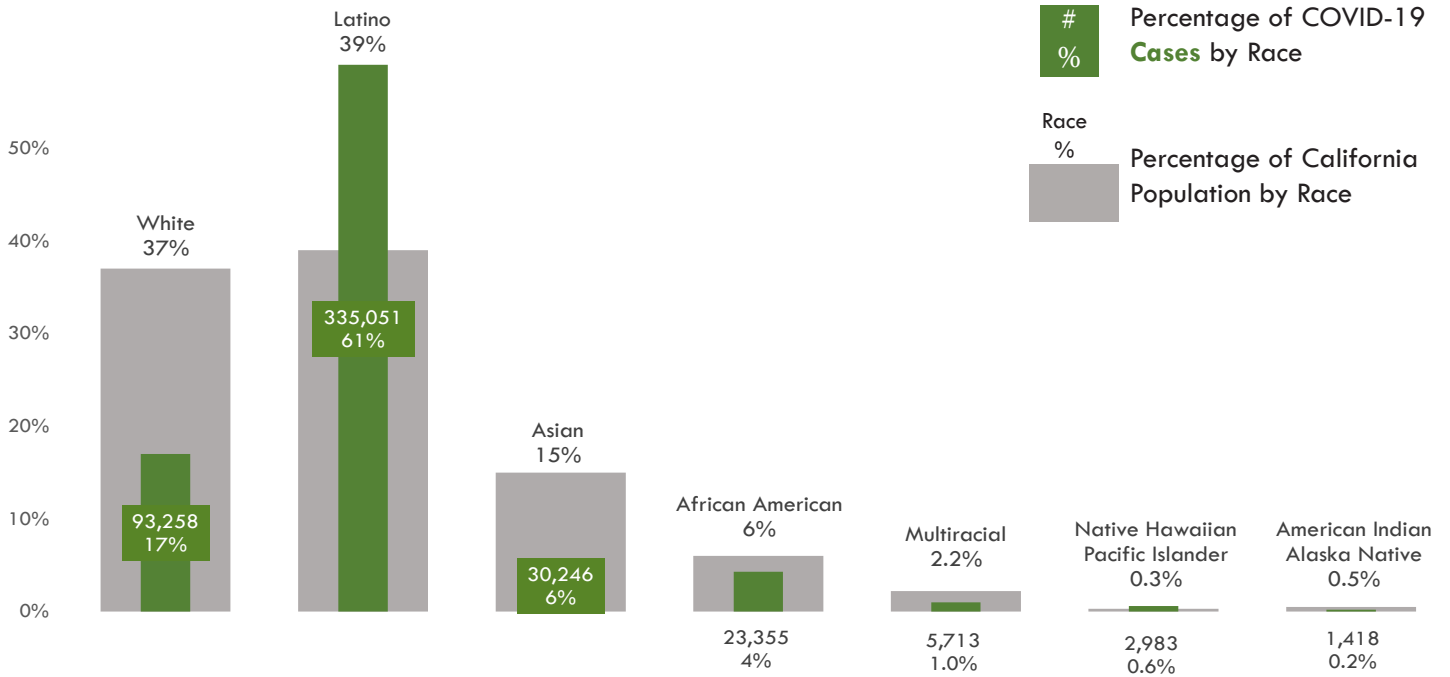
New Confirmed Deaths in California by Date



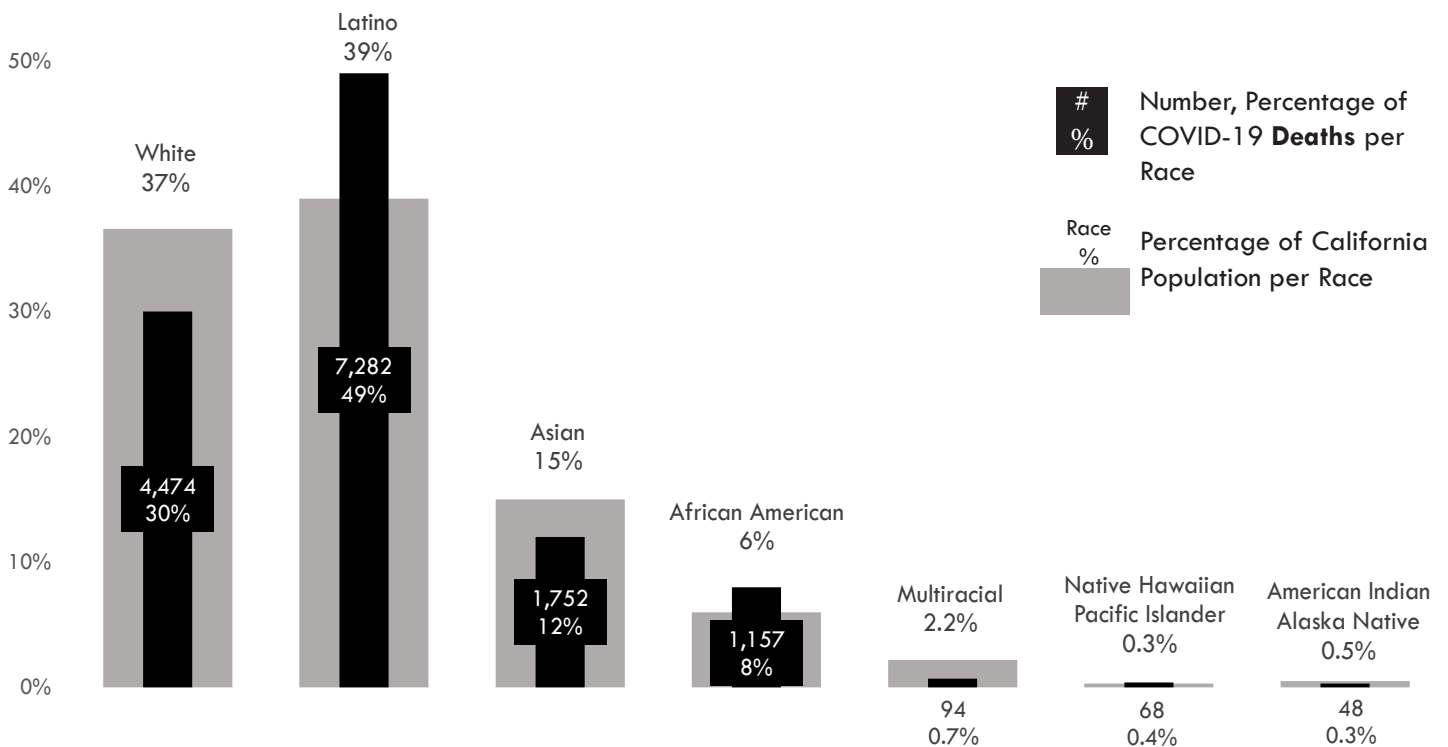

# Racial distribution of confirmed COVID-19 cases and deaths in California

American Indians and Alaska Natives account for 0.5% percent of the population, **0.2% of COVID-19 cases**, and **0.3% of deaths** in California. This includes a total of **1,418 cases** and **48 deaths** among American Indian and Alaska Native people in California.



Latinos and African Americans are dying at disproportionately high rates in California. The proportion of COVID-19 deaths in Latinos is 1.3 times their population representation across all adult age categories.

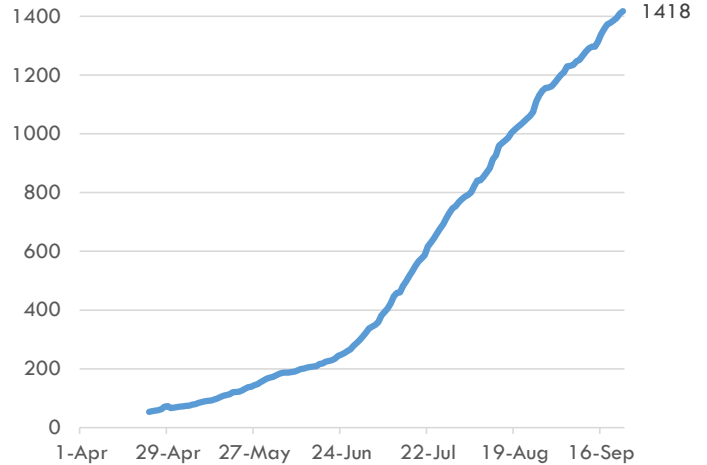
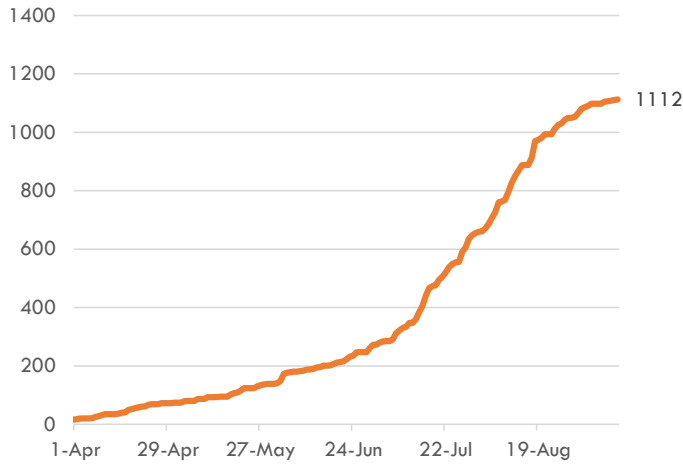

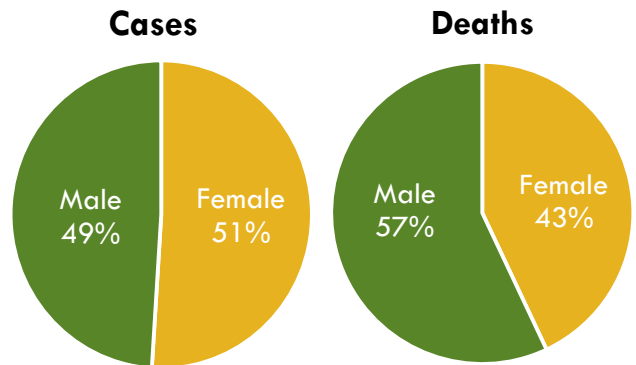
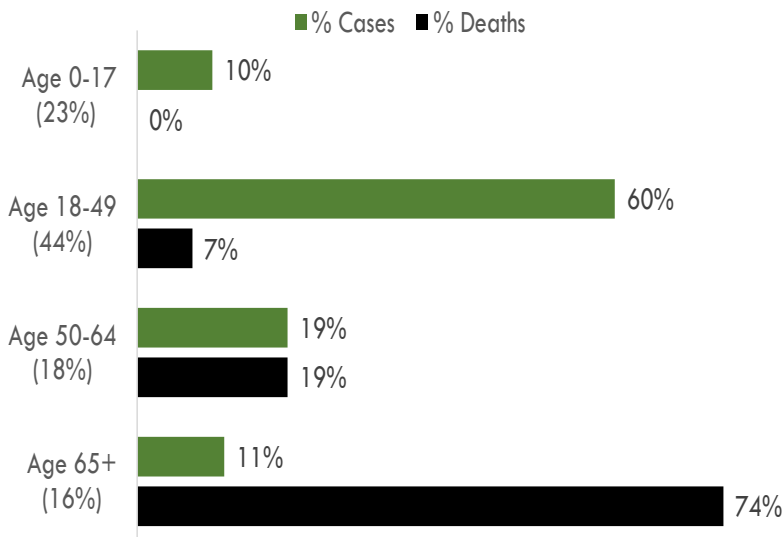

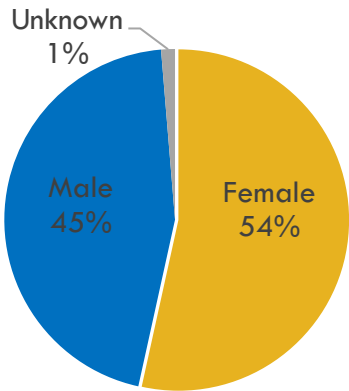

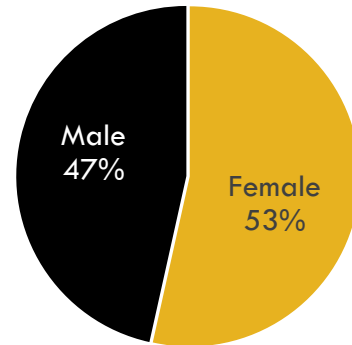
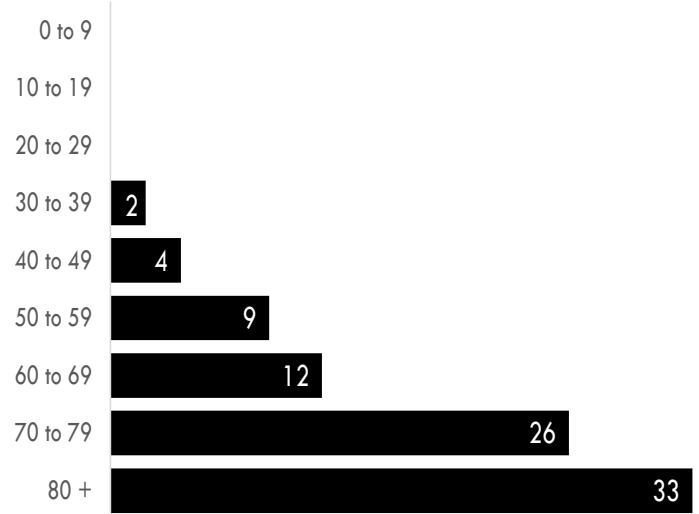

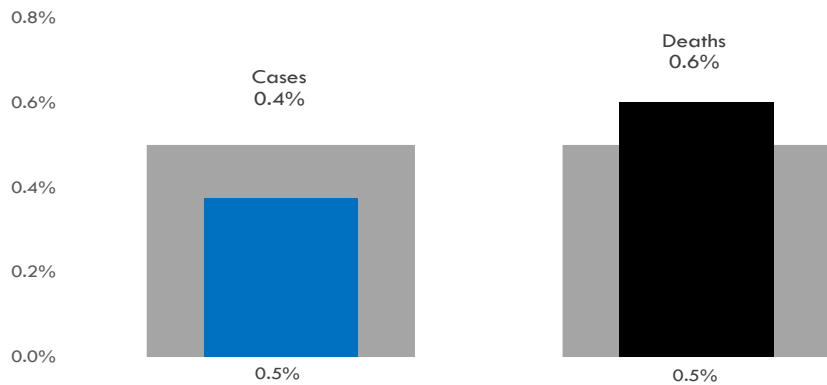
Positive COVID-19 cases among AIAN people in California by Age Group and Gender

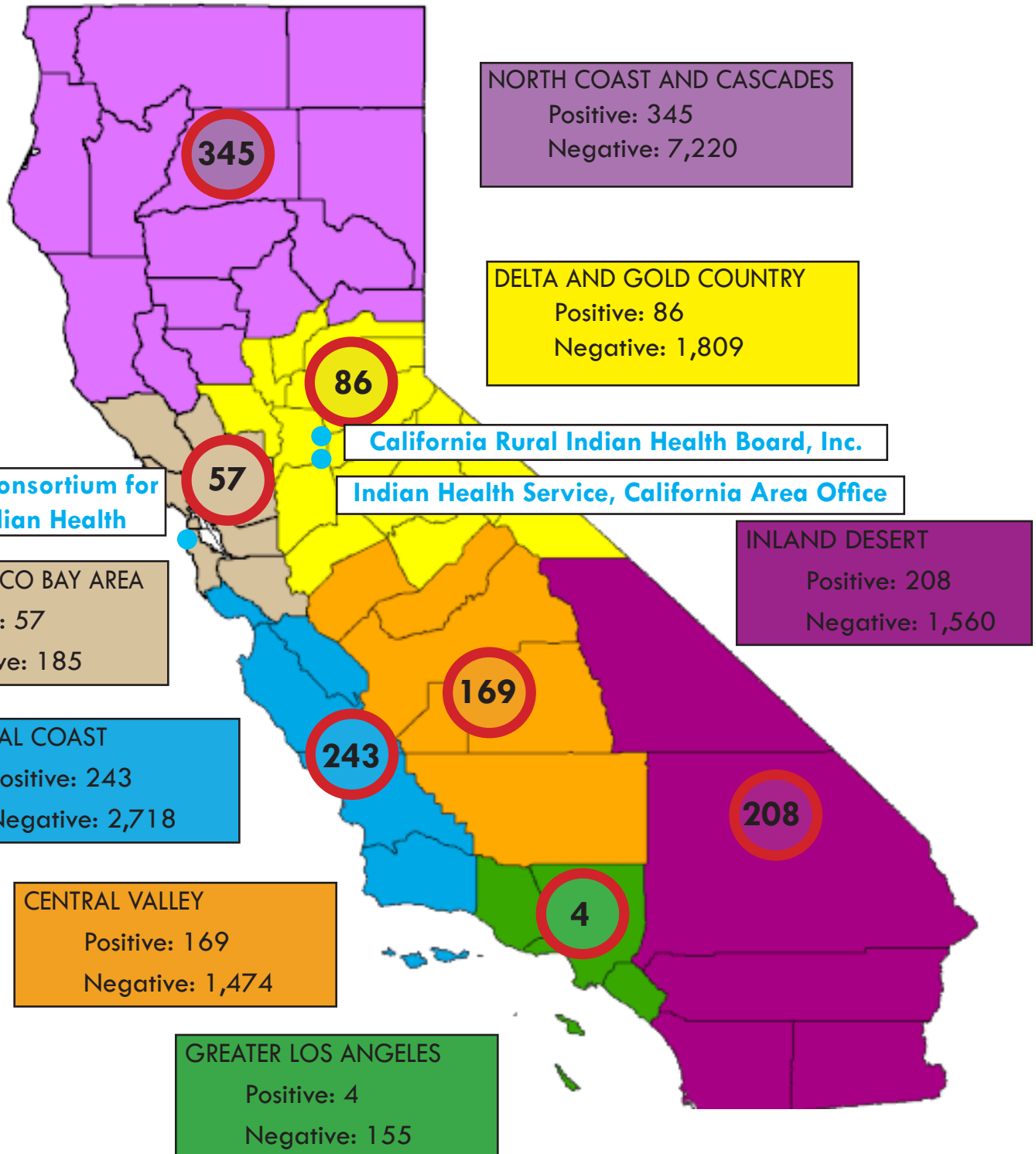

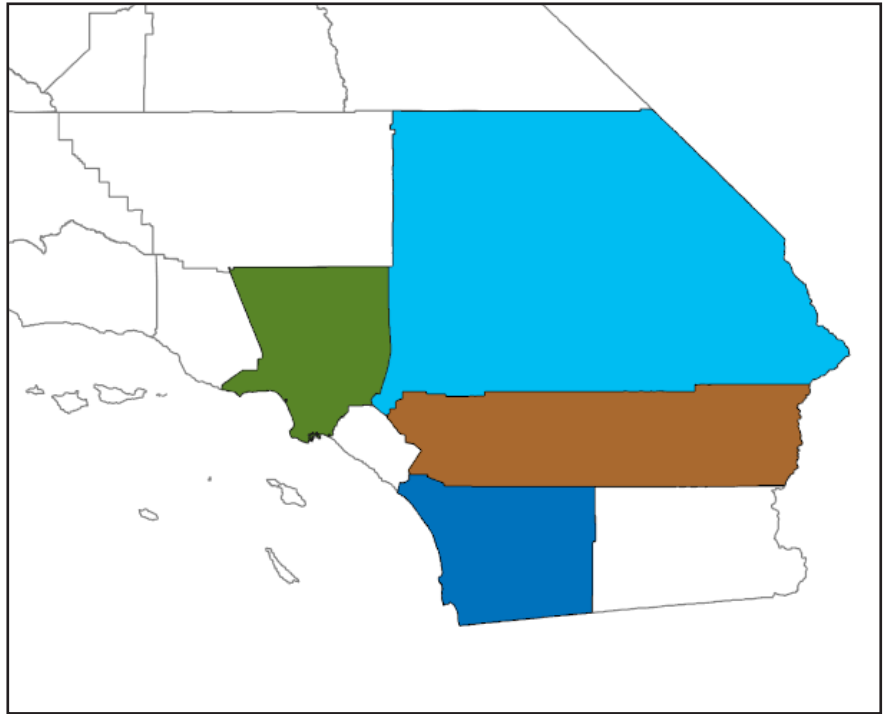

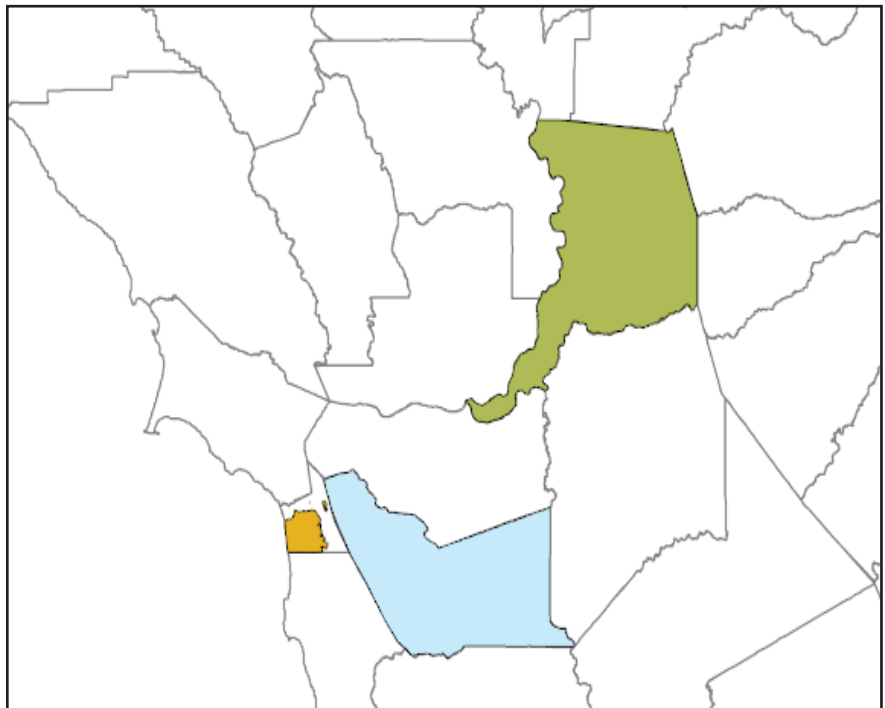
